RE: Summary of Material Modifications (SMM)

New Self-Payment and COBRA Rates For August 1, 2021 And For November 1, 2021

Dear Participant:

This SMM summarizes changes in the Fund's Self-Payment and COBRA rates, which become effective on August 1, 2021 and on November 1, 2021.

In short, on August 1 and November 1, 2021 we are raising the Self-Payment rates for most Fund participants. And, we are increasing the COBRA rates effective August 1, 2021. Below, we specifically explain these rate changes.

Q1: Who Is Affected By The August 1, 2021 Self-Payment Rate Changes?

A1: Non-Medicare Retirees, Surviving Spouses and Families with Medicare and Non-Medicare Participants (Split Contracts) will experience a monthly SelfPayment rate increase with their August 2021 Self-Payment.

Q2: Who Is Affected By The November 1, 2021 Self-Payment Rate Changes?

A2: *Self-Pay Actives* will experience a monthly Self-Payment rate increase with their November 2021 Self-Payment.

Q3: Are Medicare Retirees Affected By These Self-Payment Rate Changes?

A3: No. **Medicare Retirees** will experience *no* change in their Self-Payment rate.

Q4: What Are The August 2021 Self-Payment Rate Changes?

A4: Listed below are the *new* Self-Payment rates effective August 2021 for NonMedicare Retirees, Surviving Spouses, and Families with Medicare and NonMedicare Participants (Split Contracts).

A6: Below are the *new* COBRA rates effective August 2021.

A Final Note

We understand the impact of these rate increases. So, we raise these rates reluctantly. But, they are necessary for the prudent management of your health care program and the Fund's assets. And, we note that Active Working Fund participants share in the increases in the Fund's health care costs. Specifically, the hourly contribution rate to the Fund for active participants recently increased from \$7.51 per hour to \$7.87 per hour.
